Good News to share:

- Congratulations to Tim Stock (Philosophy) and Michèle Schlehofer (Psychology) for winning a nearly \$35K grant from the National Endowment for the Humanities for their *Re-envisioning Ethics Access and Community Humanities (R.E.A.C.H.)* Initiative. Theirs was the largest grant received in Maryland as part of the NEH's Humanities Connections program.
- Congrats as well to Joe Anderson (Mathematics & Computer Science) for winning a \$174K NSF research award to further our understanding of machine learning.
- Hats off to Catherine Jackson (IDIS Program Specialist) and students who established a SU chapter of Alpha lota Sigma. Alpha lota Sigma is an honor society for undergraduate and graduate students enrolled in interdisciplinary academic programs. The first class was inducted last month.
- We were delighted to learn that the Seidel School of Education was able to secure more than \$175K in scholarship funding for 12 SU students to be Maryland Higher Education Commission Teaching Fellows.

COVID-19 Recovery and Contingency Planning

- My 4/28 Update outlined planning at the State, USM and campus levels including our <u>COVID-19 Planning Teams</u>. The most recent campus-related COVID-19 information can be found on the <u>University's Coronavirus website</u>. We are planning for a safe return to campus, but this will necessitate that we do things differently.
- In order to support faculty development and teaching effectiveness, Melissa Thomas and
 instructional design colleagues are developing a five-module online teaching certificate.
 More on this soon, but please be thinking about support you may need to enhance your
 skills and the learning environment you want to create next academic year in whatever
 scenario we find ourselves in.
- There is much to learn from a retrospective analysis of Spring 2020 (After Action Report or AAR). For the AAR, it will be important for us to collect feedback from across the campus. A survey has been established for students in MyClasses, questions will be added to the annual Faculty Extra Instruction Productivity (FEIP) report, and a staff survey will be developed and disseminated.
- As mentioned last month, our Eastern Shore Regional GIS Cooperative developed a
 dashboard for <u>COVID-19 in Maryland</u>. In partnership with PRMC, they have also developed a
 dashboard for <u>ventilator utilization</u> in the State (Eastern and Western Shores) and DC. Great
 collaboration and important information.

Opportunities/Updates/Deadlines/Other Stuff

- The <u>Final Exam Schedule</u> remains in place as initially set. Please observe your class time/day.
- The deadline for submitting grades has been extended to 4:30 pm on May 20th (see 4/27 email from the Registrar's Office). Thanks in advance for getting your grades in by this time and date.
- Roughly 20% of students opted to change their grading method to P/NP in at least one of their courses. Our thanks to the Registrar's Office staff for all their work to make these changes for students.
- A grade of Incomplete should be awarded to a student only if the student and faculty member agree that it is appropriate and only after a plan is developed for the student to complete their work (including a timeline). Once the student completes the work, the faculty member must complete a grade change. If a grade change is not processed by Friday, December 4, the Incomplete from spring 2020 will change to an F. Faculty can require that students complete their assignments as early as is appropriate. However, the extension to Dec. 4 gives faculty more time to both work with students and grade the work before submitting a grade change.
