Faculty Senate Review

- First Faculty Senate Meeting Grad School was tabled.
- Second Faculty Senate Meeting - Robust discussion and lots of questions.
 - Group seems to support and recognize need for resources but question whether Graduate School is needed or wanted.
 - Where is the funding coming from?
 - Will this affect other student services?
 - Was tabled for further discussion.
- Was scheduled to go back on February Faculty Senate agenda but Doug is asking for a delay until Grad Council can speak to Senators and the Provost is finalized.

Reasons to Support:

- It is part of our Strategic Enrollment Plan
- President Wight wants enrollment to reach 10K. Will need to graduate enrollment to grow to achieve that growth.
- With proper growth, could be revenue neutral over time.

Most of Faculty Senate is comprised of undergrad faculty and they did not represent their constituents who support the creation of a Grad School. They need to hear from Grad Program Directors and grad faculty that this is more than a name change. Speak to your Senators and show your support.

Earliest implementation would be Fall 2020.
